But when she witnessed her father's suicidal fate, it affected her psyche. She trusted that the healing power for all her issues rests on the soul of Miss Josephine Taylor, her Governess. From the time of her birth Violeta was not allowed to be free in view of the fact of pandemic. She was under the clutch of her father, in the name of safety. She was not allowed to move outside like her brother, it bruised her a lot, this pain was within her for a long time. It was escalated further with the death of her father. After the death of her father the family moved to Nahuel, a place where they found their heaven. They were sheltered by the Rivas family. Violeta spent her maximum of best time at Santa Clara. At Nahuel, the family decided to send Violeta to boarding school, but she refused it by saying,

I announced that if they sent me away to school, I'd escape and they'd never see me again. I learn more here than at any dumb school. (Allende, 2023, p.72)

Next to her governess Miss Josephine Taylor, she was mentored by Mr. and Mrs. Rivas. She travelled with them to various places to educate the children who were potentially weak to get education. This was evidenced by the statement of Miss Taylor that,

You don't need me anymore, Violeta, now that you will be living with two wonderful teachers. (Allende, 2023, p.63)

Torito always stayed with Violeta with the fatherly care and support her throughout her life till his death. Violeta often used to scream at night as a result of her terrifying nightmare which was always first witnessed by Torito in the house, he rushed instantaneously towards her for consoling through the following words,

Sleep my little girl, go to sleep, the bogeyman is gone and won't come back.(Allende, 2023, p.78)

She was also a victim of sexual assault which bored a profound wound in her heart, which urges her to have a support in her life, this leads the way for her to choose her mate Fabian Schmidt Engler, a German immigrant veterinarian. They lived a contented life but she was not preggo for many years which affected her a lot. The inquiry posed over her by the society bruised her literally, and it blend with her psychological problem and diverted her from normal life. She accidentally got a glimpse at Julian Bravo, a Danish pilot and fell in love with him which was not known by her husband. This way of living contaminated, not only her life but also her children. As she gave more importance to physical pleasure, she failed to mend her daughter in the right way. Nieves like her father Julian has adventurous thoughts and started to follow the lifestyle of him. Violeta with her futile efforts couldn't change the path of Neives. Neives began to be very abnormal in her moral behavior and social conducts, which results in addiction of drugs too. As Violeta and Julian Bravo failed to do their duty as parents their daughter suffered in her life. Violeta went back to number of

partners like Julian which results in the death of her daughter. Violeta failed to give her valuable time to her daughter, which diverted her from day today life. This fact was accepted by Violeta in her book which states as follows,

I might have failed Juan Martin and Nieves as a mother because I was too caught up in my passion and my work, but I've been a good mother to you, Camilo. (Allende, 2023, p.312)

Violeta deliberately mourned for the death of her daughter through the following words,

I Felt like I'd been emptied out from the inside, I was a bloody cavity, I couldn't breathe, my bones were made of wax, my soul had taken flight. (Allende, 2023, p.206)

But her grief can't be paid. It was a late realization, she failed to stand by her daughter's side when Neives needed her moral support. A thing which was obtained late after its mere need ended is valued for nothing. Violeta got similar kind of anger over herself in two situations, one was during the death of her mother and another during the death of her daughter. She failed to be a perfect daughter and mother for the above relations. This was stated her as follows,

I was angry over the opportunities we missed to be mother and daughter. (Allende, 2023, p. 100)

In case of her son Juan Martin also she reminded as a passive person and never mend him the way he needed. Though she failed to be a good responsible mother for her children, she promised her grandson that she will remain a good mother to him. Failing as a mother results in spoiled life of her daughter. She couldn't raise her daughter in a disciplined way, she never tried to spend time with her and even haven't freely conversed with her. Violeta was focused in her own passion instead of anticipating about the well-being of her children. The dominance of daughter over the mother made Violeta indescribable. She gained the wonderful life education from Mr. and Mrs. Rivas which she failed to impart in her own life and the upbringing of her children. Violetta realized her mistake as an irresponsible mother which results in reckless perspective of her daughter, which was stated by her as follows,

I recalled my poor daughter, her tragic life, the drugs, the poverty, the prostitution, Joe Santoro dead from a bullet to the back of the head, Nieves's fear of her father, and Juan Martin's. I also remember the beatings and humiliations of the past, the Mafia henchmen, the CIA agents, the rolls of bills and the guns, his connection to the dictatorship. How could I have let all that happen? (Allende, 2023, p.256)

She also tells Camilo that if she returns to Earth after demise she will amend all her mistakes,

I was born in 1920, during the influenza pandemic, and I'm going to die in 2020, during the outbreak of coronavirus. What an elegant name for such a terrible scourge. I've lived a century and I have a good memory, in addition to seventy-something diaries and thousands of letters as evidence of my passage through this world. I've witnessed many events, I've amassed a lot of experience, but either because I was too distracted or too busy, I haven't acquired much wisdom. If reincarnation is real, I'll have to return to Earth to

make up for what I'm lacking. It's a terrifying prospect. (Allende, 2023, p. 313)

In her life Violeta faced many difficulties which she clearly mentioned in her novel. It is divided into four chapters. They are entitled as Exile, Passion, Absence and Rebirth. In all the phases of her living, she faced a lot of setbacks.

Allende tackles topics such as sexual assault, grief, poverty, domestic abuse, natural disaster, addiction, homophobia, and political unrest in her heartfelt prose, to name a few. The closeness we feel with Violeta makes these subjects feel all the more real and painful. (McManus, 2022, p. 56)

In the contemporary world parents are fulfilling all the wishes of their children. Parents should be more conscientious in giving freedom to the children. Bringing up the children is the most determining job one can do in their life, it should be done effectively. While bringing up the children the parents should sacrifice certain things for the well-being of their kids. Handling Juvenility is not an easiest chore, more care must be given, as children are not ready to come out of their reverie, caution must be there while handling them. Parents can teach the children to be responsible by setting up situations practically. With the developments of technology children are desperado in handling the situations.

This situation was encountered in another work titled *Mahaswetha* by Sudha Murthy. Girija was a very irresponsible girl and she had many bad conducts which was remitted by her sister-in-law Anupama. Radhakka being remiss believed her daughter but Girija used it to cheat her and spent her time lavishly with imprudent companions. The main reason for her behavior was her mother Radhakka who supports her daughter blindly against her daughter-in-law. Radhakka was very negligent in molding her daughter's character.

The nature of Girija was so annoying that Anupama found her most undisciplined child in the house. The lies are always in her talk with her mother when she convinced her for college field trip, which was never organized by her college. (Navgire, 2021, p. 138)

The reason at the rear of such kind of perception of a girl was her mother's despise towards her daughter-in-law. This corrupted her daughter's life. The remiss character of the mother leads to the reckless behavior of Girija. Not only Radhakka but also Shamanna failed to do his duty as a responsible father in the case of his daughter Anupama,

Sabakka in this story remained loyal for her daughters but failed to do so towards Anu. Shamanna lost his power and failed to stand by his daughter side. (Sundaram, 2024, p. 276)

Also, the behavior of Dr. Anand towards Anu was a result of his upbringing. His mother failed to teach him the way he should behave towards a woman. This was proved by his own statement,

Whatever I have done was wrong, but the time that I have lost cannot be recovered. (Murty, 2007, p. 128)

Even though parents provide freedom for decision making to children, they must be conscious of their decision in all stages of their life, which gives the best citizens to the society. In the observation conducted by the researcher one can come to a conclusion that parents must be valiant to address the flaws of their children. Based on the observation made everyone believe that the character of parents will be reflected in children, but in actual life
